- 7. That the District shall be a quasi-municipal corporation and political subdivision of the State of Colorado with all the powers thereof in conformity with the Service Plan, as may be amended.
- 8. Pursuant to § 32-1-306, C.R.S., a certified copy of this Order shall be recorded by the Weld County Clerk and Recorder. A copy of the approved Service Plan for Morgan Hill Metropolitan District No. 1 and the resolution of the Board of Trustees of the Town of Erie
